

Data Privacy Consent

In compliance with the Data Privacy Act ("DPA"), and its implementing rules, regulations and other issuances of the National Privacy Commission ("NPC"), Gallagher Insurance Brokers (Philippines), Inc. and its affiliates, subsidiaries, successors, and agents (collectively referred to herein as the "Company") shall lawfully collect, use, process, modify, distribute, and, as appropriate, destroy (collectively, "process") your personal information and sensitive personal information (collectively, "personal data").

This letter and consent form must be read in conjunction with Company's [Global Privacy Notice](http://www.ajg.com/global-privacy-notice) www.ajg.com/global-privacy-notice, which provides for further details on our data processing activities. In addition to your consent, the Company may rely on other lawful bases for processing your personal data as may be applicable and as provided under the DPA, such as but not limited to contractual necessity, compliance with legal obligations, legitimate interests, protection of lawful rights and interests of natural or legal persons in court proceedings, or the establishment, exercise, or defense of legal claims.

I. Authorization and Consent

These processing activities are necessary for us to fulfill our obligations to you. If you do not tick the box above, and we do not have another lawful basis to process your personal data, we may be unable to provide our services and be constrained to terminate our contract with you.

Marketing and Advertisement – To communicate or reach out to you for various purposes, including send invitations for events; advertise, market and promote services and new products, and send newsletters and offers. Improve our services – To develop, enhance or modify our services through research and development; and monitor, assess and improve our systems and platforms, including sites, algorithms, machine learning and artificial intelligence.

II. Data Sharing

We will transmit your personal data to third parties, including but not limited to within our group of companies, partners, professional advisors, and service providers, providers of insurance broking services, other third party platforms, and insurers, for the above-mentioned Purposes.

III. Rights of the Data Subject

The Company respects your rights as a Data Subject, including your right to be informed, right to access your personal data, right to rectification, erasure, data portability, and right to object to processing your personal data. To exercise any of these rights, you may send your requests, demands, complaints or notices via email to the Company Data Protection Officer at dpo.philippines@ajg.com.

You also have the right to file a complaint with the NPC or other relevant authorities, as well as the right to be indemnified, for any violation of your data privacy rights.

IV. Retention of Personal Data

Your personal data shall be retained for as long as necessary for the fulfillment of any of the Purposes, and shall continue to be retained in accordance with the Company's retention schedule notwithstanding the termination of any of the above Purposes. When we no longer need your personal data, we de-identify the data or securely destroy it based on our retention policy.
