Prizes and Fulfilment

13. **The Prizes:** A pair of tickets to a Gallagher Premiership Rugby Match. 13 pairs of tickets available to be won.
14. **Winner selection:** The Promoter will run a separate prize draw for each of the Premiership Rugby Clubs. For each prize draw, one winner will be randomly selected from all valid entries received during the Promotional period. For your total confidence, each prize draw will be conducted by an independent adjudicator who will randomly select the winners, within **7 working days** of the end of the Promotional Period.
15. **Winner Notification:** Each winner will be notified via email and/or phone within **5 working days** of winner selection, and will be required to respond to confirm eligibility and acceptance of the Prizes, within **14 days** of initial contact by following the instructions provided in the winning notification. General
