TERMS AND CONDITIONS

Full Terms & Conditions

By entering the Promotion, entrants will be deemed to be bound by and have accepted these terms and conditions. These terms and conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. - 2. **Promotion:** Enter a prize draw to win a pair of match tickets to any Gallagher Premiership Rugby match in the 24/25 season, except for the semi-final or grand final matches.
- 3. Eligibility: This Promotion is open to United Kingdom (England, Scotland, Wales and Northern Ireland) residents aged 18 or over and is free to enter. Employees (and their immediate families) of the Promoter, or the Promoter's group companies, agents or anyone else professionally connected with this Promotion are excluded.
- **4. Promotion Period:** The Promotion will run from 00:00 GMT on 16/10/24 to 23:59 GMT on 08/11/24 (inclusive).

For your total confidence, the prize draw will be conducted by an independent adjudicator who will randomly select the winner, within seven working days of the end of the Promotion Period.
- **14. Notification and Announcement of Winners:** The winner will be notified by phone and email. They will also be given instructions for claiming the Prize. The Promoter is

required to publish or make available information that indicates that a valid award took place. General

- clauses shall survive and remain in full force and effect.
